

TOKYO 2025 ARCHIVES ASSETS AGREEMENT
FOR THE WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25

THIS AGREEMENT is made

BETWEEN:

- (1) **WORLD ATHLETICS, 6-8, Quai Antoine 1er, BP 359, MC 98007 Monaco Cedex**
("WA");
- (2) **JAPAN ASSOCIATION OF ATHLETICS FEDERATIONS, Japan Sport Olympic Square**
9F, 4-2 Kasumigaokamachi, Shinjuku-ku, Tokyo 160-0013, Japan (the "OM");
- (3) **The Local Organising Committee of World Athletics Championships Tokyo 25, 4-2**
Kasumigaokamachi, Shinjuku-ku, Tokyo 160-0013, Japan (the "LOC");
- (4) **TOKYO METROPOLITAN GOVERNMENT, 8-1, Nishi-Shinjuku 2-chome, Shinjuku-**
ku, Tokyo 163-8001, Japan ("TMG");

Hereinafter jointly referred to as the "**PARTIES**" and severally as a "**PARTY**".

WHEREAS 1 WA is the ultimate proprietor of the WA - INTELLECTUAL PROPERTY RIGHTS as well as of all information, confidential business secrets and know-how relating to the organising and staging of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25.

WHEREAS 2 The LOC and the OM are responsible for the preparation and operation of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25.

WHEREAS 3 TMG is responsible for providing the necessary support to the LOC related to the preparation and operation of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25.

WHEREAS 4 This Agreement sets forth the roles of the PARTIES with regard to the TOKYO 2025 ARCHIVES ASSETS, including their management, preservation and future use in Japan in accordance with the ARCHIVAL LICENCE.

WHEREAS 5 For the purpose of fulfilling the responsibilities regarding the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 records and archives (in particular related to preservation, curation and development), an ARCHIVE ORGANIZATION shall be entrusted with the management of the TOKYO 2025 ARCHIVES ASSETS. It has been proposed, and WA has formally accepted, the appointment of the OM as the ARCHIVE ORGANIZATION with the understanding that the OM will be supported in these tasks by TMG, the LOC and potentially third parties, with the terms of such support to be further defined in an ASSET MANAGEMENT AND UTILISATION AGREEMENT to be approved in writing by WA in advance. The ARCHIVE ORGANIZATION will have the authority of the day-to-day management of the TOKYO 2025 ARCHIVES ASSETS and, on behalf of WA correspondingly, shall ensure compliance and have the right to authorise certain actions in relation to the TOKYO 2025 ARCHIVES ASSETS pursuant to the terms of this Agreement. WA will have the ultimate authority to control the TOKYO 2025 ARCHIVES ASSETS as its own proprietary assets.

WHEREAS 6 The present TOKYO 2025 ARCHIVES ASSETS AGREEMENT (the “**Agreement**”) shall follow instructions and principles of WA.

Based on the above, the PARTIES hereby agree as follows:

1. DEFINITIONS

In the context of this Agreement, the following capitalised terms shall have the meaning assigned to such terms in the present Clause 1 or otherwise they shall have the meanings assigned to such terms in this Agreement:

1.1 “**AMBUSH MARKETING**” means any advertising, communications, commercial identification, or other activity, undertaken by a person or business, that is an attempt to imply, or that results in, an unauthorised association with WA, the World Athletics Championships (including the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25), related organizations of World Athletics.

1.2 “**ARCHIVAL LICENCE**” means the non-exclusive, royalty free, revocable licence of the right related to the TOKYO 2025 ARCHIVES ASSETS which is granted by WA to the ARCHIVE ORGANIZATION (provided that the final list of TOKYO 2025 ARCHIVES ASSETS has been approved by WA), solely for carrying out its responsibilities as the custodian of the TOKYO 2025 ARCHIVES ASSETS according to this Agreement, and solely for INSTITUTIONAL PURPOSES (as defined under Clause 1.6 of this Agreement) in Japan. The ARCHIVAL LICENCE specifically includes:

- (a) the right to appraise, select and retain the TOKYO 2025 ARCHIVES ASSETS;
- (b) the right to arrange and describe the TOKYO 2025 ARCHIVES ASSETS pursuant to Appendix 3, TOKYO 2025 WORLD ATHLETICS ARCHIVE POLICY, the review of WA, and the Japanese Copyright Act, in accordance with reputable international standards and practices such as ISAD(G) or IASA;
- (c) the right to fix and reproduce the TOKYO 2025 ARCHIVES ASSETS;
- (d) the right to process, make compilations of, and take all practicable steps for the preservation of the TOKYO 2025 ARCHIVES ASSETS;
- (e) the right to make available, communicate, exhibit, present, publish and perform in public the TOKYO 2025 ARCHIVES ASSETS, exclusively for, and geo-blocked to, the territory of Japan, or otherwise as specifically approved by WA. The foregoing expressly excludes any right to broadcast (including, without limitation, over the-air television, cable television, satellite television, pay television, pay-per-view television, IPTV, video-on-demand, home video,

video downloading, mobile platform exhibition, theatrical, video streaming, radio and the Internet) the TOKYO 2025 ARCHIVES ASSETS, except with WA's, as it may correspond, prior written consent.

(f) the right to distribute copies of the TOKYO 2025 ARCHIVES ASSETS;

(g) the right to communicate to the public in any manner and through any channel or medium that the ARCHIVE ORGANIZATION or the ASSET MANAGEMENT TRUSTEE is the repository of the TOKYO 2025 ARCHIVES ASSETS, provided that it is compatible with the other provisions of this Agreement; and

(h) the right to translate and convert the TOKYO 2025 ARCHIVES ASSETS exclusively for the purposes of accessioning, exhibiting or facilitating data mining.

1.3 "**ARCHIVE ORGANIZATION**" means the organization appointed as the custodian of the TOKYO 2025 ARCHIVES ASSETS and, hence, responsible for their preservation, maintenance, and utilisation (including reception, administration, superintendence of and being responsible for) the TOKYO 2025 ARCHIVES ASSETS on behalf of WA. To this extent, upon acceptance of the final list of TOKYO 2025 ARCHIVES ASSETS by WA in accordance with Clause 1.9, WA shall appoint the OM as the Archive Organization and grant the ARCHIVAL LICENCE to them.

1.4 "**ASSET MANAGEMENT TRUSTEE**" means an organization (such as, without limitation, TMG) that, for the purpose of carrying out the operations of the ARCHIVE ORGANIZATION based on this Agreement, to support the ARCHIVE ORGANIZATION regarding the maintenance, management and/or utilization of all or part of the TOKYO 2025 ARCHIVES ASSETS, has been permitted to exercise all or part of the rights based on the ARCHIVAL LICENCE by the ARCHIVE ORGANIZATION, as per the terms of a separate agreement (the "**ASSET MANAGEMENT AND UTILISATION AGREEMENT**") as approved in writing by WA. In this regard, it is understood that the template for ASSET MANAGEMENT AND UTILISATION AGREEMENT shall be submitted by the ARCHIVE ORGANIZATION to WA for approval prior to execution. Subject to the conditions that the ARCHIVAL LICENCE is granted to the ARCHIVE ORGANIZATION and that ASSET MANAGEMENT AND UTILISATION AGREEMENT, as approved by WA, is executed between the OM and TMG, WA shall approve that the ARCHIVE ORGANIZATION appoints TMG as the ASSET MANAGEMENT TRUSTEE and sublicences the ARCHIVAL

LICENCE to TMG. In the event that the ARCHIVE ORGANIZATION appoints any entity other than TMG as an ASSET MANAGEMENT TRUSTEE and sublicences the ARCHIVAL LICENCE thereto, the ARCHIVE ORGANIZATION shall obtain the prior written approval of WA.

1.5 “***EFFECTIVE DATE***” means the date on which all PARTIES to this Agreement have signed it.

1.6 “***INSTITUTIONAL PURPOSES***” means all non-commercial and curatorial activities included or foreseen to be included in the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 LEGACY, intending to archive, preserve and manage information and physical and digital assets for the purposes of inheriting them as heritage and legacy in the territory of Japan, and in particular, for the benefit of, as it may correspond, WA and the World Athletics Championships.

1.7 “***WA - INTELLECTUAL PROPERTY RIGHTS***” means all rights, titles and interests, including intellectual property rights and any other rights on the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 (including, for the avoidance of doubt, the related events) (notably all rights, titles and interest on the TOKYO 2025 ARCHIVES ASSETS, related to the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25), whether they have been owned and/or controlled by WA from the outset, that have been transferred and assigned by the LOC, the OM and TMG to WA by means of the relevant deed of assignment. For the avoidance of doubt, the JAPANESE PARTIES hereby acknowledge and confirm that any rights, titles and interest in and to all elements, contents or works created, obtained, developed, produced or invented pursuant to or derived from WA – INTELLECTUAL PROPERTY RIGHTS, shall be the sole ownership and for the sole benefit of WA, without any restriction or encumbrance whatsoever.

1.8 “***JAPANESE PARTIES***” means the LOC (until its dissolution), the OM, and TMG.

1.9 “***TOKYO 2025 ARCHIVES ASSETS***” means the selection of assets, content or materials identified by the LOC (with the assistance from the OM and TMG) as preserving and conveying the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 2025's historical and social value for the future, produced or received by the LOC for the hosting and operation of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 2025, after the satisfactory completion by the LOC of the required preceding processes according to: (i) Japanese law

requirements (in particular, but without limitation, the Act on Protection of Personal Information of Japan, the Act on Prevention of Unfair Competition of Japan, the National Public Service Act, the Local Public Service Act, tort law/civil law and any other applicable law with regard to protection of trade secrets and confidentiality obligations); (ii) contractual or other legally binding obligations (in terms of confidentiality or otherwise); and (iii) the preservation of sensitive or strategic information. The final list of assets, content or materials constituting the “TOKYO 2025 ARCHIVES ASSETS” shall be approved in writing by WA and included as an integral part of this Agreement under Appendix 1.

1.10 “*WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 LEGACY*” means all the tangible and intangible long-term benefits for people, cities/territories with respect to and after the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25.

1.11 “*WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25*” means the 20th World Athletics Championship to take place in Tokyo, Japan, from 13 September to 21 September 2025.

2. PURPOSE

2.1 The purpose of this Agreement is to set out the arrangements for the long-term preservation of, and access to, the TOKYO 2025 ARCHIVES ASSETS in order to convey the historical and social significance of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 to the future, in accordance with the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 LEGACY.

2.2 This Agreement also sets out the obligations to report the information of the ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES to the WA correspondingly, in addition to their obligations to consult with WA on certain matters.

2.3 This Agreement further sets out the respective rights and obligations of the PARTIES in relation to the TOKYO 2025 ARCHIVES ASSETS.

3. RIGHTS IN THE TOKYO 2025 ARCHIVES ASSETS

The PARTIES acknowledge and agree that:

3.1 WA is the ultimate proprietor of all materials relating to the organising and staging of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 (including the related events) and

the corresponding WA – INTELLECTUAL PROPERTY RIGHTS. Nothing in this Agreement is intended in any way to dispute the WA’s corresponding rights (including the WA – INTELLECTUAL PROPERTY RIGHTS), in particular over the TOKYO 2025 ARCHIVES ASSETS. Nothing in this Agreement shall be construed as an assignment or a waiver of any of the WA’s rights.

3.2 The ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES shall solely and exclusively use the TOKYO 2025 ARCHIVES ASSETS, in strict compliance with the ARCHIVAL LICENCE (in particular solely for INSTITUTIONAL PURPOSES in the territory of Japan), in accordance with any other restriction and/or limitation according to this Agreement (in particular Clauses 3.3, 3.4 and 7.2 below). In this respect, and in accordance with Clause 3.5 below, it is understood that if the final list of TOKYO 2025 ARCHIVES ASSETS (as submitted by the LOC to WA) is not approved by WA, the ARCHIVAL LICENCE will not be granted to the OM (Nor shall any sublicences to TMG or other ASSET MANAGEMENT TRUSTEES be granted as a result thereof) , and no asset will be transferred from the LOC to the OM, TMG or other ASSET MANAGEMENT TRUSTEES, save where WA have given there prior written approval.

3.3 The ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES shall not exercise any of the rights granted as per the ARCHIVAL LICENCE if, as a result of doing so, they would receive any commercial benefit, excluding for reasonable fees charged to cover the costs related to granting access to the general public to the TOKYO 2025 ARCHIVES ASSETS and to maintain the records stored in the ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES owned or controlled archives (i.e. operational costs in connection with the ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES exercising/performing their rights under this Agreement). Furthermore, the ARCHIVE ORGANIZATION and the ASSET MANAGEMENT TRUSTEES shall not exercise any of the rights set out above if, as a result of doing so, any third party would receive any commercial benefit.

3.4 The ARCHIVE ORGANIZATION and the other JAPANESE PARTIES (in particular when acting as ASSET MANAGEMENT TRUSTEES) shall not engage in any form of AMBUSH MARKETING or knowingly facilitate any third party in engaging in AMBUSH MARKETING. The JAPANESE PARTIES shall consult with WA (as it may correspond), in order to prevent any use of the TOKYO 2025 ARCHIVES ASSETS in any AMBUSH MARKETING activity by others. In addition, the JAPANESE PARTIES shall jointly and severally procure that no third party shall be granted any right to sponsor or otherwise

associate itself with the TOKYO 2025 ARCHIVES ASSETS, the World Athletics Championships (including the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25), WA and its affiliated entities, without the prior written consent of WA. The JAPANESE PARTIES shall jointly and severally procure that they will take all diligent and reasonably necessary steps to actively prevent and prohibit the direct or indirect use of the TOKYO 2025 ARCHIVES ASSETS in any AMBUSH MARKETING activity by a third party, to the extent permitted under the relevant laws and regulations of Japan.

3.5 The JAPANESE PARTIES acknowledge and agree that the ARCHIVAL LICENCE will be granted by the WA to the ARCHIVE ORGANIZATION only if, and after, the final list of TOKYO 2025 ARCHIVES ASSETS is accepted in writing by the WA (and integrated to this Agreement as Appendix 1).

4. ROLES AND RESPONSIBILITIES

4.1 The roles and responsibilities of the ARCHIVE ORGANIZATION and the other JAPANESE PARTIES (to the extent they act as ASSET MANAGEMENT TRUSTEES) in order to maintain, manage, and utilise the TOKYO 2025 ARCHIVES ASSETS smoothly and efficiently in the future are detailed in Appendix 2.

4.2 The JAPANESE PARTIES shall sincerely discuss, if the respective roles and responsibilities of the JAPANESE PARTIES regarding the maintenance, management, utilisation and cost allocation of the TOKYO 2025 ARCHIVES ASSETS changes in order to maintain, manage and utilise the TOKYO 2025 ARCHIVES ASSETS smoothly and efficiently in the future, based on reasonable standards. In this respect, the JAPANESE PARTIES agree that any such change shall be approved in writing by WA in advance.

5. TRANSFER OF THE TOKYO 2025 ARCHIVES ASSETS

5.1 The TOKYO 2025 ARCHIVES ASSETS, once approved in writing by WA, shall be transferred from the LOC to the ARCHIVE ORGANIZATION. The ARCHIVE ORGANIZATION shall then store and take over the TOKYO 2025 ARCHIVES ASSETS, in compliance with the terms of this Agreement and with the instructions and requests of the LOC and WA.

6. POST-TRANSFER OBLIGATIONS

6.1 The ARCHIVE ORGANIZATION will acquire, arrange, describe, preserve, maintain, and utilise the TOKYO 2025 ARCHIVES ASSETS in compliance with professional international

archival standards, Appendix 3, TOKYO 2025 WORLD ATHLETICS ARCHIVE POLICY, and any requirements of relevant laws of Japan.

6.2 The ARCHIVE ORGANIZATION shall apply appropriate conservation treatments and make repairs to the TOKYO 2025 ARCHIVES ASSETS as necessary in order to ensure the long-term integrity and availability of such assets.

6.3 The ARCHIVE ORGANIZATION shall take all reasonable precautions compatible with providing access to the public to protect the TOKYO 2025 ARCHIVES ASSETS from damage, loss or theft, and additional or fraudulent modifications.

6.4 The ARCHIVE ORGANIZATION will provide appropriate notices of the copyright of the TOKYO 2025 ARCHIVES ASSETS to those accessing these assets (with references to the WA, as applicable). As a general rule, the copyright notice for assets for which WA holds the rights shall be as follows, and if any other notice is to be used, the ARCHIVE ORGANIZATION shall obtain WA's prior written approval: for assets the rights of which are held by WA: © *YEAR – World Athletics - All rights reserved.*

6.5 The ARCHIVE ORGANIZATION will provide a written activity report of the preservation and use of the TOKYO 2025 ARCHIVES ASSETS to WA once a year from 2026 and 2027 and as requested by WA afterwards. The activity reports will be prepared with the cooperation of the ASSET MANAGEMENT TRUSTEE and shall include all activities related to the TOKYO 2025 ARCHIVES ASSETS.

6.6 The ARCHIVE ORGANIZATION shall obtain prior written consent of WA prior to entering into an ASSET MANAGEMENT AND UTILISATION AGREEMENT with any ASSET MANAGEMENT TRUSTEE (i.e.: the template for ASSET MANAGEMENT AND UTILISATION AGREEMENT shall be approved beforehand) and supervise and be responsible and liable for all activities performed by the ASSET MANAGEMENT TRUSTEES as well as for their compliance with the terms of this Agreement (including the Appendices). In the event another JAPANESE PARTY (i.e.: the LOC, or/and TMG) is acting as an ASSET MANAGEMENT TRUSTEE, the ARCHIVE ORGANIZATION and any such JAPANESE PARTY shall be jointly and severally liable to WA with regard to (i) the management and utilisation of the assets covered by the ASSET MANAGEMENT AND UTILISATION AGREEMENT concluded between the ARCHIVE ORGANIZATION and the concerned other JAPANESE PARTY, or (ii) the roles assigned to such concerned other

JAPANESE PARTY.

7. UTILISATION OF TOKYO 2025 ARCHIVES ASSETS

7.1 Subject to the limitations under this Agreement (in particular Clause 3.4, 3.5 and 7.2) and within the scope of the rights granted under the ARCHIVAL LICENCE, the ARCHIVE ORGANIZATION shall take such reasonably necessary steps as required to make the TOKYO 2025 ARCHIVES ASSETS available for public use, with particular attention being placed on TOKYO 2025 ARCHIVES ASSETS on digital media.

7.2 Regarding the utilisation of the TOKYO 2025 ARCHIVES ASSETS, the ARCHIVE ORGANIZATION shall strictly observe the following:

(a) the ARCHIVE ORGANIZATION may only permit the TOKYO 2025 ARCHIVES ASSETS to be used by the public for personal, non-commercial and temporary purposes, including research and private study and in compliance with all applicable laws, and will take the reasonable and diligent necessary steps to inform users of the TOKYO 2025 ARCHIVES ASSETS of such restrictions (e.g. through terms of use or legal notices);

(b) the ARCHIVE ORGANIZATION shall take all steps that may reasonably be required, to the extent permitted under the relevant laws and regulations of Japan, in order to prevent the use of the TOKYO 2025 ARCHIVES ASSETS for commercial purposes by third parties or purposes unrelated to the promotion of the World Athletics Championships, or in any other manner that would be unlawful, and to terminate such unauthorised use by third parties as soon as practically possible;

(c) the ARCHIVE ORGANIZATION may restrict access for a period to records or other assets which need conservation or preservation actions. These records or other assets may be made available under controlled access conditions during this time if appropriate.

7.3 When providing access to the TOKYO 2025 ARCHIVES ASSETS to the public, the ARCHIVE ORGANIZATION may charge for a reasonable extent of expenses required to maintain the TOKYO 2025 ARCHIVES ASSETS that it controls, in accordance with Clause 3.3.

7.4 Notwithstanding Clause 7.3, the ARCHIVE ORGANIZATION shall ensure that, except at times when it is impractical to do so, any third party authorised by WA has unfettered access

to the TOKYO 2025 ARCHIVES ASSETS during normal business hours, free of any charge.

7.5 WA or any third party authorised by them may request a digital copy at no cost or a physical copy, subject to payment of normal copying charges, of any part of the TOKYO 2025 ARCHIVES ASSETS or of any information related to those assets, and the ARCHIVES ORGANIZATION shall provide such a copy as soon as reasonably practicable, usually within twenty (20) BUSINESS DAYS after receipt of the request. For the purpose of this Agreement, “**BUSINESS DAYS**” shall include any day except Saturday, Sunday and official bank holidays in Japan, and from 29 December to 3 January.

7.6 The ARCHIVE ORGANIZATION shall agree to promptly inform (in any case within fifteen (15) BUSINESS DAYS upon knowledge) WA (as it may correspond) about any third parties’ misuse of the TOKYO 2025 ARCHIVES ASSETS.

7.7 When acting as ASSET MANAGEMENT TRUSTEES to support the ARCHIVE ORGANIZATION regarding the maintenance, management and/or utilization of some of the TOKYO 2025 ARCHIVES ASSETS, TMG shall strictly comply with all obligations and requirements imposed to the ARCHIVE ORGANIZATION according to this Agreement (in particular, but without limitation, Clauses 3.2, 3.3, 3.4 and 7 as well as with the terms of the ARCHIVAL LICENCE).

8. CONFIDENTIALITY

8.1 All information, shared by any PARTY to other PARTY; or that a PARTY had access to in connection with this Agreement, will be maintained in strict confidence and not be disclosed to third parties, except:

(a) where the JAPANESE PARTY, who supplied the information, as well as WA give its prior written consent;

(b) as required to carry out the PARTIES’ obligations under this Agreement;

(c) if disclosed to the minimum extent necessary to lawyers, accountants and other professionals who bear legal obligations of confidentiality equivalent (or stricter) to those imposed on the PARTIES according to this Agreement and where necessary for the performance of this Agreement;

(d) if required by law, in which case the disclosure will be made to the minimum extent necessary according to the procedures specified in such law;

(e) with regard to the existence and content of this Agreement (including the final list of TOKYO 2025 ARCHIVES ASSETS and any assets contained therein (provided, however, that such assets are limited to disclosure in accordance with the disclosure policy accepted by WA), but excluding any other information referred to in this Agreement);

(f) when strictly concerning each PARTY's respective directors, officers, employees, auditors, representatives, agents, subcontractors or otherwise, and where strictly and legitimately required, on a "need to know" basis, whenever such individuals are bound in writing to observe the confidentiality obligations of this Agreement or similarly stringent provisions and solely for the specific purpose of implementing this Agreement, with the understanding that such disclosure shall be limited to the relevant parts of this Agreement.

8.2 In the event that any of the JAPANESE PARTIES intends to disclose the existence and content of this Agreement pursuant to Clause 8.1(e), reasonable advance written notice shall be provided to WA before public disclosure, giving full details of the foreseen disclosure and its purpose(s) and objective(s).

8.3 The obligations of this Clause 8 shall remain valid after the termination of this Agreement.

9.1 Any notice, request, or communication in connection with this Agreement must be in writing and, if sent by post, shall be addressed as follows:

9.2 Any written notice, request, or communication sent in connection with this Agreement may, as an alternative to being sent by post:

(a) be delivered in person during normal business hours and left with the addressee or any other responsible employee at the relevant address set out herein; or

(b) be sent by facsimile transmission or email, provided receipt thereof is confirmed by a recipient who is authorised to do so.

9.3 Any PARTY to this Agreement may from time to time change its address for the giving of any notice, request or communication under this Agreement by giving notice to all PARTIES.

10. TERMINATION OF THIS AGREEMENT

10.1 This Agreement is valid from the EFFECTIVE DATE and shall remain valid indefinitely unless otherwise terminated pursuant to Clauses 10.2, 10.3, 10.4 or 10.5. For the avoidance of doubt, the PARTIES expressly agree that this Agreement will not enter into force so long as this Agreement has not been signed by all the PARTIES.

10.2 Either JAPANESE PARTY (the “**WITHDRAWING PARTY**”) shall be authorised to withdraw from this Agreement upon written notice to the other PARTIES (the “**REMAINING PARTIES**”) and WA. In such case, the REMAINING PARTIES and WA shall, within sixty (60) days following the written notice from the WITHDRAWING PARTY, decide whether

the collaboration undertaken according to this Agreement can continue without the WITHDRAWING PARTY (in which case this Agreement shall be amended accordingly) or if this Agreement shall terminate, subject to approval from WA, and decide upon the date of termination and steps to be taken to that end by the PARTIES. The WITHDRAWING PARTY shall indemnify the REMAINING PARTIES and WA for all costs incurred, including during the WITHDRAWAL PERIOD (as defined below). The withdrawal shall be effective on the first BUSINESS DAY following the twelve (12) months term after all PARTIES and WA have been effectively notified by the WITHDRAWING PARTY (the “**WITHDRAWAL PERIOD**”).

10.3 In the event that a JAPANESE PARTY cannot or does not perform its obligations according to the terms of this Agreement (the “**BREACHING PARTY**”) due to a reason related to such BREACHING PARTY (including, without limitation, breach of the Agreement or bankruptcy), any of the other PARTIES may request (via written notice) the BREACHING PARTY to remedy the situation within thirty (30) days. If the BREACHING PARTY fails to remedy the situation within such period of time, upon at least thirty (30) days prior written notice (sent to the BREACHING PARTY and the other PARTIES), (i) the other JAPANESE PARTIES may decide to remove the BREACHING PARTY from the Agreement (with the prior written approval from WA) and (ii) WA may decide to remove the BREACHING PARTY from this Agreement. In such case, the other PARTIES shall decide whether the collaboration undertaken according to this Agreement can continue without the BREACHING PARTY (in which case this Agreement shall be amended accordingly) or if this Agreement shall terminate at the time of removal of the BREACHING PARTY. The BREACHING PARTY shall take all necessary measures in order to ensure the continuity of the collaboration under this Agreement (until and after the date of removal) at its own costs and indemnify the other JAPANESE PARTIES and WA for all damages and costs incurred as a result of such removal.

10.4 In addition to the termination events included under Clauses 10.2 and 10.3 here above, WA may at any time and without liability, revoke the ARCHIVAL LICENCE granted to the ARCHIVE ORGANIZATION with twelve (12) months prior written notice (unless otherwise reasonably agreed in good faith between the PARTIES) sent to the ARCHIVE ORGANIZATION (with copies to the other PARTIES), whenever WA objectively and reasonably consider at its sole discretion that the purposes and objectives of this Agreement have not been, or will likely not be, achieved in the manner, level or form expected by WA. The Agreement would terminate at the time the ARCHIVAL LICENCE terminates.

10.5 In the event WA definitively refuses the final list of TOKYO 2025 ARCHIVES ASSETS

submitted by the LOC, then this Agreement would terminate with immediate effect, save where agreed otherwise between the PARTIES.

10.6 In the event this Agreement is terminated (for any reason whatsoever), the ARCHIVE ORGANIZATION shall transfer the TOKYO 2025 ARCHIVES ASSETS to third parties designated by WA before the effective date of termination of this Agreement. The costs related to such transfer of the TOKYO 2025 ARCHIVES ASSETS shall be borne by:

- The WITHDRAWING PARTY in case of termination according to Clause 10.2;
- The BREACHING PARTY in case of termination according to Clause 10.3 (provided the BREACHING PARTY has been found liable by a competent court);
- WA in case of termination according to Clause 10.4 (save where WA revoked the ARCHIVAL LICENCE due to a reason attributable to a JAPANESE PARTY (such as, without limitation, breach of the Agreement or bankruptcy) in which case the costs shall be borne by such JAPANESE PARTY);
- The ARCHIVE ORGANIZATION in any other cases.

10.7 The loss of legal personality due to the dissolution and liquidation of the LOC shall not constitute 'withdrawal' as defined in Clause 10.2, and this Agreement shall not terminate upon the disappearance of the LOC but shall remain valid and continue among the remaining Parties. However, if the other Parties determine that the cooperation under this Agreement cannot continue without the LOC, such Parties may terminate this Agreement under conditions separately stipulated by them.

11. NO ASSIGNMENT OR WAIVER

11.1 The JAPANESE PARTIES shall not assign or transfer to third parties, provide as collateral, or otherwise dispose of this Agreement, their status under this Agreement and the rights and obligations arising therefrom without the prior written consent of all the other PARTIES. Any such assignment, transfer, disposition or act without the relevant written consents shall be null and void.

11.2 The PARTIES acknowledge and agree that no failure on the part of a PARTY to exercise, and no delay in exercising, any right under this Agreement shall operate as a waiver thereof, nor shall any single or partial exercise by a PARTY of any right under this Agreement preclude any other or future exercise thereof or the exercise of any other right.

12. LIABILITY

12.1 The ARCHIVE ORGANIZATION, and the other JAPANESE PARTIES when acting as ASSET MANAGEMENT TRUSTEES, will take all reasonable precautions compatible with the provision of public access to protect the TOKYO 2025 ARCHIVES ASSETS from damage, loss or theft and from additions or fraudulent amendments, and shall be liable to WA for any damage to, or loss or theft of, the TOKYO 2025 ARCHIVES ASSETS or any part of it during the term of this Agreement. In this respect, it is understood that the measures implemented by the ARCHIVE ORGANIZATION (and the other JAPANESE PARTIES when acting as ASSET MANAGEMENT TRUSTEES) to protect the TOKYO 2025 ARCHIVES ASSETS shall be no less protective than the measures normally used by archival entities at the international level in accordance with internationally recognised professional standards.

12.2 The ARCHIVE ORGANIZATION and the other JAPANESE PARTIES (to the extent they act as ASSET MANAGEMENT TRUSTEES), upon transfer of the TOKYO 2025 ARCHIVES ASSETS (from the LOC), shall indemnify and hold WA, including its directors, employees, representatives and agents, harmless from any claim, liability or expense (including any and all legal fees) arising from, or in connection with, any third party's claim that may arise from the storage, conservation and management of the TOKYO 2025 ARCHIVES ASSETS. However, this shall not apply to any matters arising from reasons attributable to WA, including its directors, employees, representatives and agents.

13. MISCELLANEOUS

13.1 Except as otherwise set out herein, each JAPANESE PARTY will be responsible for the costs and expenses in relation to this Agreement, in particular with regard to its respective activities. The ARCHIVE ORGANIZATION undertakes to accept and store the TOKYO 2025 ARCHIVES ASSETS at the ARCHIVE ORGANIZATION's premises (or another location approved by WA), without any fee or charge for WA.

13.2 In the case that any provision of this Agreement may be invalid, illegal or unenforceable, such provision shall be interpreted so as to reflect the intent of the PARTIES as closely as possible, to the maximum extent permitted by the applicable laws. The remaining provisions of this Agreement shall remain valid and shall continue to bind the PARTIES.

13.3 The PARTIES guarantee that they will at all times comply with all applicable laws and regulations related to their activities pursuant to this Agreement, including (without limitation) all applicable anti-bribery and anti-corruption laws (some of which may have an extra-territorial reach) and respect the principles contained in the United Nations Guiding

Principles on Business and Human Rights.

13.4 The JAPANESE PARTIES shall be responsible for the respect of any requirements under all applicable data protection, privacy or similar laws and regulations (including, without limitation, the laws of Japan) that apply to its respective activities in relation to this Agreement.

13.5 Nothing in this Agreement shall create or be construed to create a relationship of partnership or joint venture between the PARTIES, or any of them.

13.6 The JAPANESE PARTIES jointly agree and confirm that this Agreement as well as any and all amendments or modifications to this Agreement, after consultation and agreement by all JAPANESE PARTIES, will need prior written approval of WA. Any modification or amendment made without such prior approval shall be null and void.

14. GOVERNING LAWS AND DISPUTE RESOLUTION

14.1 This Agreement shall be interpreted in accordance with the laws of Japan.

14.2 The PARTIES shall attempt to resolve any dispute or claim arising between the PARTIES out of this Agreement by way of prompt negotiations. If any such dispute or claim is not so resolved by the PARTIES by way of negotiations within a reasonable period of time (but, in any case, no more than thirty (30) days), each PARTY may refer it for adjudication by the courts in accordance with Clause 14.3.

14.3 The PARTIES agree that any dispute relating to this Agreement (including any mediation proceeding of the court) will be subject to the exclusive jurisdiction of the Tokyo District Court.

14.4 The PARTIES will make reasonable efforts to continue complying with this Agreement while a dispute or claim is being resolved. With respect to any dispute that causes it to be economically or technically difficult for a PARTY to continue to comply with this Agreement, the PARTIES shall make all reasonable efforts to expedite the dispute process.

15. SUPPLEMENT

15.1 Any matter that raises doubts in the interpretation of this Agreement and any matter that

is not stipulated in this Agreement shall be submitted to WA. In this regard, it is understood that upon first consultation between all JAPANESE PARTIES, their preliminary conclusions shall be submitted to WA for final assessment and decision on interpretation. WA shall consider it on an objective basis pursuant to the nature and objectives of this Agreement in each case.

APPENDIX 2

ROLES AND RESPONSIBILITIES OF THE JAPANESE PARTIES

The main roles of the LOC are:

- (a) To submit the final list of TOKYO 2025 ARCHIVES ASSETS to WA for approval.
- (b) To transfer the TOKYO 2025 ARCHIVES ASSETS to the ARCHIVE ORGANIZATION (provided the final list of TOKYO 2025 ARCHIVES ASSETS has been approved by WA) .
- (c) To participate in decisions and related activities undertaken among the PARTIES until its dissolution.

The main roles of the OM (the ARCHIVE ORGANIZATION) are:

- (a) To act as the custodian of the TOKYO 2025 ARCHIVES ASSETS based on the ARCHIVAL LICENCE that will be granted by WA (subject to the acceptance of the final list of TOKYO 2025 ARCHIVES ASSETS by WA).
- (b) To maintain, manage, utilise and promote the use of the TOKYO 2025 ARCHIVES ASSETS in order to convey the legacy of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 to future generations.
- (c) To designate JAPANESE PARTIES (or, where applicable, third parties), excluding the LOC, as ASSET MANAGEMENT TRUSTEES (as per the terms of the ASSET MANAGEMENT AND UTILISATION AGREEMENT (the template of which shall be submitted by the ARCHIVE ORGANIZATION to WA for prior written approval before entering into the ASSET MANAGEMENT AND UTILISATION AGREEMENT)) and to entrust all or part of the operations to such ASSET MANAGEMENT TRUSTEE(S), for the purpose of carrying out its obligations under this Agreement. ASSET MANAGEMENT TRUSTEES may be authorised to exercise some of the rights granted to the ARCHIVE ORGANIZATION under the ARCHIVAL LICENCE on its behalf, provided they comply with all terms, conditions, obligations and objectives under this Agreement (in particular Clauses 3, 5, 6 and 7 of this Agreement). The ARCHIVE ORGANIZATION shall supervise and be responsible and liable for all activities performed by the ASSET MANAGEMENT TRUSTEES and for their compliance with the terms and conditions of this Agreement (and of the ASSET MANAGEMENT AND UTILISATION AGREEMENT) in accordance with Clause 6.6. Where the ASSET MANAGEMENT TRUSTEE is TMG, TMG and OM shall be jointly and severally liable to WA for the management and utilisation of the assets managed by TMG.

TOKYO 2025 ARCHIVES ASSETS AGREEMENT
FOR THE WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25

The main roles of TMG (the ASSET MANAGEMENT TRUSTEE) are:

- (a) To support the ARCHIVE ORGANIZATION in maintaining, managing and utilising the TOKYO 2025 ARCHIVES ASSETS in order to convey the legacy of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 to future generations.
- (b) To act as an ASSET MANAGEMENT TRUSTEE in strict compliance with the terms of this Agreement and the ASSET MANAGEMENT AND UTILISATION AGREEMENT, as approved by WA, and, in this capacity, to carry out and be responsible for the storage and utilisation of a part of the TOKYO 2025 ARCHIVES ASSETS.

Any change in the roles and/or responsibilities of the JAPANESE PARTIES under this Appendix 2 shall be submitted to WA for its prior written approval.

Appendix 3

TOKYO 2025 WORLD ATHLETICS ARCHIVE POLICY

1. Position and Purpose of This Policy

The “TOKYO 2025 WORLD ATHLETICS ARCHIVE POLICY” (hereinafter referred to as the “Policy”) sets out the policy framework for the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS listed in Appendix 1 (Final List of the TOKYO 2025 ARCHIVES ASSETS) to TOKYO 2025 ARCHIVES ASSETS AGREEMENT FOR THE WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 (hereinafter referred to as the "Agreement") approved by WA. The purpose of this Policy is to promote a shared understanding among the successor organizations of the basic framework and mechanisms necessary to ensure the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS.

2. TOKYO 2025 ARCHIVES ASSETS

(1) Definition of the TOKYO 2025 ARCHIVES ASSETS

The TOKYO 2025 ARCHIVES ASSETS mean those assets, content or materials produced or received by the LOC for the purpose of the organisation and operation of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 which have been identified by the LOC, with the support of the OM and TMG, as assets that convey the historical and social value of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 to future generations.

The TOKYO 2025 ARCHIVES ASSETS shall, upon obtaining WA’s approval of Appendix 1, which constitutes the final list of the assets, content and materials comprising the TOKYO 2025 ARCHIVES ASSETS, be transferred to the ARCHIVE ORGANIZATION and succeeded¹ to the ARCHIVE ORGANIZATION and any ASSET MANAGEMENT TRUSTEES acting on its behalf in part.

¹ The term “succession” refers solely to the transfer of physical custody of the assets and does not imply the transfer of any rights that continue to vest in WA, including ownership and intellectual property rights, to the extent such rights remain subject to the applicable provisions. The term “succession” as used throughout this Policy shall have the same meaning in all instances.

(2) Scope and Classification of the TOKYO 2025 ARCHIVES ASSETS

The TOKYO 2025 ARCHIVES ASSETS are classified into tangible assets and documentary assets, as set out below.

(a) Tangible Assets

Tangible assets are broadly divided, as shown in the table on the following page, into artifacts and memorabilia² and audiovisual materials³.

These assets refer to those that reflect the image of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 (e.g. event decorations and medals) or that strongly preserve the memory of athletes' performances (e.g. competition equipment such as hurdles), and that contribute to the transmission of the legacy of the WORLD ATHLETICS CHAMPIONSHIPS to future generations.

In principle, tangible assets are limited to those produced by the LOC⁴.

(b) Documentary Assets

Documentary assets refer to documents that need to be succeeded to as records of, or operational know-how relating to, the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25, as well as documents of cultural, educational or historical value, including various publications and reports.

² "Artifacts and Memorabilia" refer to items that symbolically represent the functions of each FA ("Artifacts") and items that embody the memories and stories of the event ("Memorabilia"). Specific examples are set out in the Asset Classification Table on the following page. (For the purposes of this Policy, "FA" is an abbreviation for "Functional Area" and refers to a department within the LOC responsible for the provision of a specific set of services and related services.)

³ "Audio and/or Visual Materials" refer to materials that record information perceivable visually, aurally, or both, including still images such as photographs, moving images, and audio recordings. Specific examples are set out in the Asset Classification Table on the following page.

⁴ "Archives Assets" are defined as assets created or received for the purposes of event operations and other related activities that are intended to convey historical and social value to future generations. As a conceptual matter, this definition may include assets created by entities other than the LOC (including WA or TMG). However, with respect to the Archives Assets of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25, all such assets were at one time held by the LOC and therefore, in practice, fall into either assets created by the LOC or assets received by the LOC.

3. Successor Organizations


The successor organizations that succeed to the TOKYO 2025 ARCHIVES ASSETS and assume responsibility for their preservation, management and utilisation shall include the following organizations:

ARCHIVE ORGANIZATION: Japan Association of Athletics Federations (the OM)

ASSET MANAGEMENT TRUSTEES (*): Parties to this Agreement (TMG), and other entities

(*) ASSET MANAGEMENT TRUSTEES mean entities that are authorised, in accordance with the terms of a separate agreement approved in writing by WA (the ASSET MANAGEMENT AND UTILISATION AGREEMENT⁵), to exercise the ARCHIVAL LICENCE on behalf of the ARCHIVE ORGANIZATION (the OM). The template of such an agreement shall be subject to WA’s approval prior to execution.

⁵ “ASSET MANAGEMENT AND UTILISATION AGREEMENT” means a separate agreement, approved in writing by WA, entered into between the ARCHIVE ORGANIZATION (the Japan Association of Athletics Federations) and an ASSET MANAGEMENT TRUSTEE, for the purpose of supporting the ARCHIVE ORGANIZATION’s (the Japan Association of Athletics Federations) obligations under this Agreement, by supporting the ARCHIVE ORGANIZATION (the Japan Association of Athletics Federations) for the preservation, management and utilisation of all or part of the TOKYO 2025 ARCHIVES ASSETS.

4. Preservation, Management and Utilisation after Succession

With respect to the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS, the ARCHIVAL LICENCE that may be exercised by each successor organization and the responsibilities assumed by such organizations are as set out below.

The specific details thereof are stipulated in the ASSET MANAGEMENT AND UTILISATION AGREEMENT entered into by the relevant ASSET MANAGEMENT TRUSTEES.

(1) ARCHIVAL LICENCE

The ARCHIVE ORGANIZATION has been granted by WA an ARCHIVAL LICENCE that enables non-commercial and curatorial activities carried out for the purpose of preserving, managing and utilising the TOKYO 2025 ARCHIVES ASSETS received by it.

ASSET MANAGEMENT TRUSTEES, on the other hand, may exercise such licence on behalf of the ARCHIVE ORGANIZATION by entering into an ASSET MANAGEMENT AND UTILISATION AGREEMENT with the ARCHIVE ORGANIZATION and upon WA granting permission for the ARCHIVE ORGANIZATION to sublicense such licence to the relevant ASSET MANAGEMENT TRUSTEE.

The specific rights included in the ARCHIVAL LICENCE⁶ are as follows:

- (a) The right to appraise, select and retain the TOKYO 2025 ARCHIVES ASSETS.
- (b) The right to arrange⁷ and describe⁸ the TOKYO 2025 ARCHIVES ASSETS in accordance with internationally recognised standards and practices, this Policy, any review by WA, and applicable Japanese copyright laws (for example, the preparation of asset inventories).
- (c) The right to fix and reproduce the TOKYO 2025 ARCHIVES ASSETS (primarily digital assets), including, for example, recording onto storage media and making physical reproductions (primarily in printed form).
- (d) The right to process, edit and take all feasible measures necessary for the preservation of

⁶ Only to the extent that the relevant provisions of this Agreement and the ASSET MANAGEMENT AND UTILISATION AGREEMENT, which form the basis of the ARCHIVAL LICENCE, are applicable.

⁷ For the purposes of this Policy, "Arrangement" means organising the TOKYO 2025 ARCHIVES ASSETS in a clear and systematic manner so as to identify what types of such assets exist.

⁸ For the purposes of this Policy, "Description" means recording the arranged information in catalogues or similar instruments.

the TOKYO 2025 ARCHIVES ASSETS (for example, measures to prevent deterioration and the updating of preservation files).

(e) The right, limited to use within Japan and subject to geo-blocking⁹ outside Japan, or as otherwise individually approved in writing by WA, to make available, communicate, exhibit, present, publish and perform the TOKYO 2025 ARCHIVES ASSETS (for example, in-gallery exhibitions, screenings and the production of pamphlets).

The foregoing does not include the right to broadcast the TOKYO 2025 ARCHIVES ASSETS, unless WA, at its discretion, grants prior written approval on a case-by-case basis.

For the avoidance of doubt, with respect to audiovisual materials, making such materials accessible via the internet is deemed by WA to constitute broadcasting of the TOKYO 2025 ARCHIVES ASSETS; accordingly, prior written approval from WA is required even where geo-blocking is applied.

(f) The right to distribute reproductions of the TOKYO 2025 ARCHIVES ASSETS (for example, the provision of printed materials).

(g) The right, in accordance with this Agreement, to communicate the TOKYO 2025 ARCHIVES ASSETS to the public (for example, the online publication of inventories limited to access within Japan).

(h) The right, solely for the purpose of facilitating access, exhibition and data mining¹⁰, to translate and convert the TOKYO 2025 ARCHIVES ASSETS (for example, the preparation of Japanese-language translations for explanatory purposes).

⁹ “Geo-blocking” refers to a technology that imposes certain restrictions based on the geographic location of a user attempting to access content (in particular, content accessed via the internet). Specifically, where the TOKYO 2025 ARCHIVES ASSETS are made accessible online, they must be configured so as to prevent access from locations outside Japan.

¹⁰ “Data mining” refers to techniques for analysing large volumes of collected data in order to identify correlations, patterns and other relationships.

Notes: Restrictions on the Storage, Management, and Utilisation of the TOKYO 2025 ARCHIVES ASSETS¹¹

(i) Secondary Use

Secondary use involving the editing or modification of the TOKYO 2025 ARCHIVES ASSETS to create new works falls outside the scope of the ARCHIVAL LICENCE and is not permitted.

Where secondary use is desired, prior written approval must be obtained separately at WA's discretion.

(ii) Restrictions on Audiovisual Materials

Among the TOKYO 2025 ARCHIVES ASSETS, audiovisual materials may be stored, managed, and utilised only in accordance with the usage conditions set forth below¹².

¹¹ The restrictions concerning secondary use and audiovisual materials are illustrative only and are not exhaustive. Any use of the Archives Assets in a manner not expressly permitted under this Agreement or the ASSET MANAGEMENT AND UTILISATION AGREEMENT shall not be allowed. Furthermore, the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS shall be carried out in accordance with WA's policies and related guidelines.

¹² Among the audiovisual materials, the following two categories may be used without obtaining WA's consent, provided that such use is limited to within Japan and that access from outside Japan is restricted through geo-blocking: (i) Still images that do not contain any marks, indications or names relating to the World Athletics Championships, and that are not competition-related images of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25 (including, for example, images of practice sessions, competitions or ceremonies); and (ii) Digitised versions of physical media assets (including electronic versions of official posters).

(iii) Preservation, Management and Utilisation by WA and Other Parties

In the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS, the successor organizations shall comply with the instructions and principles of WA. In addition, third parties authorised by WA shall, except where doing so would be impracticable for the successor organizations, be permitted to freely access the TOKYO 2025 ARCHIVES ASSETS free of charge during normal business hours. Furthermore, any future digitisation of the TOKYO 2025 ARCHIVES ASSETS shall require the prior written approval of WA.

(iv) Documentary Assets

With respect to documentary assets designated as “Restricted-User Documents” in the TOKYO 2025 ARCHIVES ASSETS List, such documents contain knowledge, expertise and other information relating to the preparation and operation of the WORLD ATHLETICS CHAMPIONSHIPS TOKYO 25. Accordingly:

- (i) access to such documents shall be limited to potential organisers of international sporting events and to all parties to this Agreement; and
- (ii) records of the use of such documents shall be promptly reported by the ARCHIVE ORGANIZATION to WA, and WA shall also be entitled to utilise such documents.

(2) Responsibilities

Each successor organization shall be primarily responsible for the following matters with respect to the preservation, maintenance and utilisation of the TOKYO 2025 ARCHIVES ASSETS:

- (a) complying with professional international archival standards (*) and this Policy, as well as applicable laws and regulations of Japan.
- (b) ensuring integrity¹³ and availability¹⁴ through appropriate preservation treatments and repairs.
- (c) taking preventive measures against damage, loss, theft, and similar risks.
- (d) implementing the necessary measures to enable public use solely for personal, non-commercial, and temporary purposes. Such measures include, for example, the establishment of a contact point to receive requests for public use for these purposes.
- (e) prohibiting any commercial use or any use that constitutes ambush marketing.
- (f) reporting activities to WA (the ASSET MANAGEMENT TRUSTEES shall submit their activity reports to OM, and OM shall compile and submit such reports to WA; such reporting shall be conducted once per year until 2027, and thereafter as requested by WA).

These refer to internationally recognized and credible standards, namely international standards and guidelines issued by leading professional organizations that internationally oversee “archival institutions” engaged in the collection, preservation, and provision of cultural and historical information resources, such as museums and libraries. Successor organizations shall refer to domestic standards and guidelines formulated based on such international standards.

¹³ “Integrity” means the protection of the assets from damage, alteration, or any other unauthorized modification.

¹⁴ “Availability” means the existence of an environment in which users are able to securely access the assets when needed; provided, however, that certain assets may be subject to access restrictions.

(3) Third-Party Use by Loan

Where a third party requests the loan of part of the TOKYO 2025 ARCHIVES ASSETS from an ASSET MANAGEMENT TRUSTEE, the ASSET MANAGEMENT TRUSTEE may loan the relevant assets to the third party, provided that it confirms the purpose and manner of use with the third party and ensures that the following conditions¹⁵ are complied with.

- (a) The third party's purpose of use shall be limited to personal, non-commercial and temporary purposes. Any loan for purposes other than those set out above shall require the prior written consent of WA, to be obtained through the ARCHIVE ORGANIZATION.
- (b) The ASSET MANAGEMENT TRUSTEE shall ensure that the third party complies with the provisions of this Agreement, the ARCHIVAL LICENCE and the ASSET MANAGEMENT AND UTILISATION AGREEMENT. This includes, without limitation, compliance with internationally recognised archival standards and the prohibition of commercial use and ambush marketing¹⁶.

In addition, where audiovisual materials in electronic form are recorded onto external electronic storage media (including DVDs, USB devices and hard disk drives) and loaned to a third party by physically providing such media, prior consent of WA must be obtained for the initial act of recording onto such media. For the avoidance of doubt, where the relevant media recorded with WA's consent, or copies thereof, are subsequently loaned, no further consent of WA shall be required, unless otherwise specifically provided in this Agreement or the ASSET MANAGEMENT AND UTILISATION AGREEMENT, provided that such loans comply with the other applicable provisions of this Agreement.

Supplementary Provisions (Effective Date and Scope)

This Policy constitutes a summary of the provisions applicable to the successor organizations with respect to the preservation, management and utilisation of the TOKYO 2025 ARCHIVES ASSETS. Any matters not set out in this Policy shall be governed by the provisions of this Agreement and the ASSET MANAGEMENT AND UTILISATION AGREEMENT.
